**OBC candidates**

Candidate belonging to OBC Category who has submitted certificate issued prior to November, 2022 (OBC Certificate more than one year old) is required to submit a new OBC NCL Certificate or an affidavit regarding continuing his/her Non Creamy Layer status OR candidate who has submitted certificate issued prior to November, 2020 (OBC Certificate more than three years old) is required to submit a new valid certificate by 5.00 pm on 05.11.2023 (at helpline email ID [rajmedicoallotments@gmail.com](mailto:rajmedicoallotments@gmail.com)) failing which he/she will not be considered eligible for benefit of reservation under OBC NCL category.

**EWS candidates**

Candidate belonging to EWS Category who has submitted certificate which is not valid for financial year 2023-24 is required to submit a EWS certificate valid for financial year 2023-24 or an affidavit regarding continuing his/her EWS status OR candidate who has submitted certificate issued prior to financial year 2021-22 is required to submit a new valid certificate by 5.00 pm on 05.11.2023 (at helpline email ID [rajmedicoallotments@gmail.com](mailto:rajmedicoallotments@gmail.com)) failing which he/she will not be considered eligible for benefit of reservation under EWS category.
